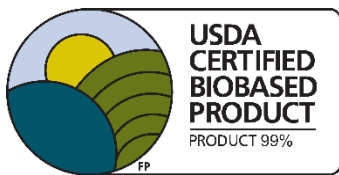
Process

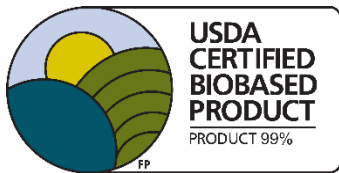
